ABOUT NEW CASTLE COUNTY

A Brief History

English navigator, Henry Hudson, first discovered what is presently known as the State of Delaware in 1609 after being hired by the Dutch to locate and explore the Northwest Passage. In 1631, the Dutch attempted to establish permanent settlements on the land, but their efforts proved to be unsuccessful. Swedish colonization began seven years later at Fort Christina, near the present-day city of Wilmington. By 1664, local settlements had become predominantly English, and the land was transferred to

William Penn in 1682 as Pennsylvania's "Lower Three Counties" identified as New Castle, St. Jones, and Deale. The counties of St. Jones and Deale were later renamed Kent and Sussex, respectively. After the end of the American Revolution, Delaware became the first state to ratify the U.S. Constitution on December 7, 1787.

Geography

New Castle County is Delaware's northernmost county, bordered by Pennsylvania to the north, Maryland to the west, the Delaware River to the east, and Kent County to the



south. It is the smallest county in Delaware, with a total land area of 426 square miles. Two of the State's major cities, Newark and Wilmington, find their home in New Castle County. Wilmington is the largest incorporated city in Delaware, with a population of 70,851.

The northern quarter of New Castle County falls within the Appalachian Piedmont and contains rolling hills and small valleys. The remaining portion of the County is located in the Atlantic Coastal Plain, separated by the Atlantic Seaboard Fall Line, which passes through the cities of Newark and Wilmington. Land elevation ranges from sea level to 447.85 feet at Ebright

Azimuth, the highest point in Delaware. The local climate is moderate, with average temperatures reaching 86°F in the summer and 24°F in the winter. The average annual rainfall is 44 inches.


ABOUT NEW CASTLE COUNTY (CTD.)

Population

Although New Castle County is the smallest county in the State, it remains to be the most populated. According to statistics recorded by the U. S. Census Bureau in 2010, New Castle County's population is estimated for 2013 to be 549,684, with a population density of 1,290 persons per square mile.

As of 2015, there were 207,723 households in New Castle County, with an average household size of 2.54 people. The median ages of New Castle County residents is 35 years, the same as the national average, and lower than the median age of 36.7 for Delaware in 2010. In 2010, 32.5 percent of households had children under 18 years of age and 25.7 percent of households have members 65 years and over. By 2030, over 27 percent of New Castle County's residents will be over the age of 60. Similarly, the racial composition of the County has become increasingly diverse and will become even more diverse over the next 25 years (source: 2012 Comprehensive Development Plan for New Castle County and US Census Bureau).



EMERGENCY MANAGEMENT: AN INTRODUCTION

What is Emergency Management?

Emergency management is the managerial function charged with creating the framework within which communities reduce vulnerability to hazards and cope with disasters.

Principles

Emergency management must be:

Comprehensive – emergency managers consider and take into account all hazards, all phases, all stakeholders, and all impacts relevant to disasters.

Progressive – emergency managers anticipate future disasters and take preventative and preparatory measures to build disaster-resistant and disaster-resilient communities.

Risk-driven – emergency managers use sound risk management principles (hazard identification, risk analysis, and impact analysis) in assigning priorities and resources.

Integrated – emergency managers ensure unity of effort among all levels of government and all elements of a community.

Collaborative – emergency managers create and sustain broad and sincere relationships among individuals and organizations to encourage trust, advocate a team atmosphere, build consensus, and facilitate communication.

Coordinated – emergency managers synchronize the activities of all relevant stakeholders to achieve a common purpose.


Flexible – emergency managers use creative and innovative approaches in solving disaster challenges.

Professional – emergency managers value a science and knowledge-based approach based on education, training, experience, ethical practice, public stewardship and continuous improvement.

HISTORY OF EMERGENCY MANAGEMENT/NCC OEM

Emergency Management in New Castle County

The New Castle County Office of Emergency Management established its roots during the late 1970s, when an increase in local population growth prompted the Department of Public Safety to establish a Planning Office to assist with the management of local emergencies. The Office of Emergency Preparedness was subsequently established in 1980 to handle the increased requirements for local planning and emergency management grant funding, appointing Richard Kendall to fill the only position within



the Office as the Coordinator of Emergency Planning for NCC. By 1985, Coordinator Kendall also had been named Chairman of the Delaware City Community Awareness and Emergency Response Group (DCCAER), an organization created to develop outreach and response plans for the chemical complexes concentrated in the Delaware City area. Later that year, the first Planner position was added to the Office to handle the Radiological Emergency Planning and the evacuation planning for County facilities. In the fall of 1988, the Office of Emergency Preparedness developed the first County Emergency Operations Plan, promulgated by County Executive Greenhouse in March 1989. An additional Planner position was created in 1990 to handle natural hazards emergency planning efforts, and the County established its first Emergency Operations Center at the NCC Airport Terminal Building later that year. A third planning position was added in 1991 for chemical emergency planning. In the years to follow, New Castle County's Office of Emergency Preparedness became heavily involved in the response to various events that affected both the County and the region, such as Tropical Storm Floyd in 1999; the Motiva Enterprises sulfuric acid explosion in 2001; Hurricane Isabel in 2003; and an F2 tornado in 2004 which impacted both the New Castle County Airport and surrounding communities. In 2005, under the leadership of Coordinator Joe Leonetti, the Office of Emergency Preparedness was renamed to the Office of Emergency Management and was established as its own Division under the rejuvenated Department of Public Safety. The Office was later relocated to its current home at the Paul J. Sweeney Public Safety Headquarters, equipped with a new 2,800-square-foot Emergency Operations Center and office space to accommodate up to 8 staff members. Shortly thereafter in July 2007, Dave Carpenter Jr. was promoted to be the Office's Coordinator of Emergency Management for New Castle County. Effective in late 2014, OEM is now operating under the Division of Emergency Communications, with a total of 6 Full Time employees.


Community Partnerships

GOALS & OBJECTIVES

The New Castle County Office of Emergency Management has worked to identify and prioritize various goals to be completed within a two-year period. The goals found on the following pages have been divided among five functional groups—Emergency Operations Center/Incident Response, Citizens Corps Program, Planning, Training/Exercises, and Administration/Finance. Each goal contains one or more objectives, followed by their respective implementation strategies.

EMERGENCY OPERATIONS CENTER/INCIDENT RESPONSE

GOAL 1: Effectively develop and link local and county response capabilities and resources to state and private response capabilities and resources.

- **1.1** Improve inter-agency coordination through establishing relationships and planning and response efforts.
 - <u>Task 1.1.1</u> Enhance integration of multi-agency, state, private & volunteer response entities through the facilitation of resource management.
 - ➤ Increase participation in inter-agency committees that foster coordination (i.e., Marine Committee, Fire Chief's Association, Transportation Management Team, and Delmarva Task Force).
 - <u>Task 1.1.2</u> Maintain a network with municipal EOC's & coordination of municipal organizations.



- **1.2** Provide coordination and support of location evacuations & protective actions for sheltering in place.
 - Task 1.2.1 Maintain a database of available shelters and current contact information.
 - <u>Task 1.2.2</u> Seek available funding for improvements identified in the 2010 engineering study.
 - <u>Task 1.2.3</u> Notify and coordinate activation of community shelter components which include general population, medical needs, companion animal component, and unattended children component.
 - Task 1.2.4 Determine shelter locations based upon incident information.
- 1.3 Provide coordination and support of special operations teams.
 - <u>Task 1.3.1</u> Maintain the mobile laptops to the 5 fire service special operations teams.
 - <u>Task 1.3.2</u> Maintain the inventory of personal protective equipment and homeland security issued assets for NCC Public Safety.

GOAL 2: Continue to enhance EOC Operations to improve readiness, situational awareness, communications, and public notification.

- **2.1** Maintain primary and backup EOC in a state of readiness & capability for long-term operations.
 - <u>Task 2.1.1</u> Develop procedures for EOC activation and representatives based on an all-hazard approach.
 - <u>Task 2.1.2</u> Continue updating EOC manuals for radiological incidents.
 - <u>Task 2.1.3</u> Perform tests of primary and secondary EOC on a quarterly basis.



- <u>Task 2.1.4</u> Continue to train on current EOC activation log and work with the State to improve or replace current system.
- <u>Task 2.1.5</u> Develop an integrated resource management database that could interface with the EOC activation log.
- 2.2 Maintain capability for the establishment of IR support in the field and/or mobile EOC capability.
 - <u>Task 2.2.1</u> Maintain and improve current utility vehicle fleet, trailer fleet, and equipment.
 - Task 2.2.2 Upgrade information technology equipment for field deployment.
- 2.3 Maintain primary & secondary communications capabilities for EOC & field operations.
 - <u>Task 2.3.1</u> Maintain test and improve equipment and staffing for amateur radio communications within the EOC and vehicle fleets.
 - <u>Task 2.3.2</u> Establish amateur radio communications for backup EOC and develop protocols for deployment of "go-kits".
 - <u>Task 2.3.3</u> Maintain and test public safety radio, satellite phone capabilities, and Delaware's Warning and Alert System (DEWAS) for EOC and field operations.
 - <u>Task 2.3.4</u> Manage and maintain procedures for the County's Government Emergency Telecommunication System (GETS)/Wireless Priority Service (WPS) account and the teleconferencing system.

- **2.4** Provide continuity services for alternate sites and shelters.
 - <u>Task 2.4.1</u> Maintain preventative maintenance program and load testing for continuity generators.
 - <u>Task 2.4.2</u> Develop protocols for deployment of continuity generators with OEM fleet vehicles
- **2.5** Develop and promote situational awareness through technology to present a common operating picture.
 - <u>Task 2.5.1</u> Embrace NCC's GIS abilities to utilize and enhance this capability within the EOC and field operations.
 - <u>Task 2.5.2</u> Develop a method of recording damage assessments from CAD and Hansen programs into a GIS picture.
 - <u>Task 2.5.3</u> Maintain a tracking database of critical infrastructure, their plans, and mitigation actions through the use of GIS.
 - <u>Task 2.5.4</u> Develop a GIS resource management and tracking capability to integrate state and regional efforts in this area.
 - <u>Task 2.5.5</u> Acquire the authorization and capability from DelDOT to view the traffic cameras in the EOC/911 Center.
- **2.6** Maintain, manage, and coordinate the activation of alerts/warning systems for the public and/or agencies, and provide coordinated alerts for large-scale events.
 - <u>Task 2.6.1</u> Initiate contact lists, develop SOP's, conduct tests, and manage activations of the Delaware Emergency Notification System (DENS).
 - <u>Task 2.6.2</u> Monitor and initiate Emergency Alert System (EAS)/Emergency Messaging Network (EMnet) messages to alert the public of emergencies through the media outlets and EOC's.
 - <u>Task 2.6.3</u> Support the Delaware Environmental Observation System (DEOS) flood warning gauges and utilize the system for monitoring meteorological situations and damage assessments.

CITIZEN CORPS PROGRAM

GOAL 3: Continue to foster preparedness education, training and volunteerism through the NCC Citizen Corps Council.

- **3.1** Increasing preparedness knowledge provided to community organizations.
 - <u>Task 3.1.1</u> Conduct outreach presentations.
 - > NCC OEM will conduct outreach presentations to foster a greater understanding of disaster planning, response and recovery throughout the public and private sectors.
 - The Citizen Corps council will facilitate publication of education efforts about the Citizen Corps programs through the county's website, Citizen Corps blog and Facebook page, and government access cable television station.
- 3.2 Conduct various Citizen Corps training programs.
 - <u>Task 3.2.1</u> Provide CERT training with CPR and AED training to NCC residents free of charge.
 - <u>Task 3.2.2</u> Partnering members of the council will be utilized to identify the specific training needs and opportunities with special needs populations.
 - <u>Task 3.2.3</u> The Citizen Corps Council will facilitate publication of training events about the Citizen Corps programs through the county's website, Citizen Corps blog and Facebook page, and government access cable television station.
- 3.3 Recruit new disaster volunteers through the various programs.
- 3.4 Obtain and administer grant funding for Citizen Corps CERT & VIPS.
 - <u>Task 3.4.1</u> In an effort to minimize program expenses derived from local budgets, the Citizen Corps Council will endeavor to seek a variety of funding mechanisms to support Corps programs, including federal and state grants and continue researching other possible options for the future.
- **3.5** Continuing participation in & support of AmeriCorps Emergency Services Program.
 - <u>Task 3.5.1</u> Host at least one ESC member full-time within NCC OEM.
 - <u>Task 3.5.2</u> Hold annual AmeriCorps CERT training for all Delaware AmeriCorps members and have ESC and AmeriCorps members cross-trained by partnering organizations as needed.



PLANNING

- **GOAL 4:** Establish planning teams to create, develop, revise, and renew plans to make them both operational and compliant with federal and industry standards.
- **4.1** Update and promulgate NCC's major plans in a more operationally functional format conducive to ICS structure, and integrate them with State and municipal plans.
 - <u>Task 4.1.1</u>- Continue to revise and update the NCC Comprehensive Emergency Management Plan (CEMP), the NCC Threat Incident Management Plan (Facility Evacuation Plan), the Hazardous Substance Response Plan, and the Delaware City-Community Awareness and Emergency Response Plan.
 - <u>Task 4.1.2</u> Conduct and revise hazard vulnerability studies and assessments that provide a foundation for more focused planning process.
 - <u>Task 4.1.3</u> Provide guidance, direction, and assistance with critical infrastructure plans, dam safety, medical and long term care facilities, and child care facilities, to include business, industry, and faith based organizations.
 - <u>Task 4.1.4</u> Revise the FEMA-required, multi-jurisdictional All-Hazard Mitigation Plan on a five-year basis and update the mitigation actions, projects, and Community Rating System (CRS) program annually.
- **4.2** Establish and maintain a Continuity of Operations Plan (COOP) for NCC to include alternate government site plans and logistical support.
 - <u>Task 4.2.1</u>- Complete and distribute00 the NCC COOP and conduct annual revisions. Maintain a disaster recovery software agreement and planning assistance contract, if feasible.
 - Task 4.2.2 Identify and commit resources to NCC alternate sites and complete exercises.
 - <u>Task 4.2.3</u> Maintain preventative maintenance contract and load testing programs for continuity generators. Provide logistical support for generator resources.
 - <u>Task 4.2.4</u> Develop and maintain resources to support NCC employee evacuation shelters and safety measures.
 - <u>Task 4.2.5</u> Align NCC needs with any State COOP plans and support capabilities for improved 911 fold down/ relocation.

TRAINING & EXERCISES

- **GOAL 5:** Assure that New Castle County maintains a comprehensive, all-hazards training and exercise program that effectively evaluates and tests all aspects of local emergency management systems.
- **5.1** Develop a training program for both internal and external stakeholders that will address emergency management plans, operations, and functional components.
 - <u>Task 5.1.1</u> Complete annual orientations on NCC's Threat Incident Management Plan.
 - <u>Task 5.1.2</u> Sponsor and conduct training for EOC and field operations.
 - <u>Task 5.1.3</u> Provide training and orientation on COOP.
- **5.2** Conduct and sponsor various exercises to test and subsequently improve response and planning efforts.
 - <u>Task 5.2.1</u> According to NIMS and HSEEP guidelines, establish the 3 year exercise plan in cooperation with DEMA and the City of Wilmington.
 - <u>Task 5.2.2</u> Plan and conduct any DC CAER or facility exercises within NCC.
 - <u>Task 5.2.3</u> Conduct at least two drills of each County site under the Threat Incident Management Plan.
- **5.3** Support and participate in REP medical and functional exercises planned by DEMA.
 - <u>Task 5.3.1</u> Assist in planning and support for the annual Medical Drill, the Biennial Graded Plume Exercise, and the 6 year Ingestion Pathway Exercise.
 - <u>Task 5.3.2</u> Conduct quarterly EOC drills with staff and include EOC representatives every 6 months.



ADMINISTRATION & FINANCE

- **GOAL 6:** Retain fiscal and administrative responsibility through budgetary, grant management, sustainment of grants and revenues, and compliance with standards and accreditation entities.
- **6.1** Review on an annual basis all budgets to make certain the Office of Emergency Management remains fiscally responsible while providing efficient and effective service to the community.
 - <u>Task 6.1.1</u> Create yearly budgets for NCC Operating, EMPG, and Radiological program to align with strategic plan, and submit budgets for supplemental funding when appropriate.
 - <u>Task 6.1.2</u> Review budgets each month to make certain all purchases are following strategic guidelines and plans.
 - <u>Task 6.1.3</u> Assure that all steps are taken to make certain projects are complete as fiscally conservative as possible while following procurement guidelines.
- **6.2** Maintain Grant levels, strive for supplemental funding, and maintain reimbursement processing to assure continual funding of programs and services.
 - <u>Task 6.2.1</u> Provide yearly reviews, grant budget and work plans to DEMA for EMPG, REP, and any additional programs.
 - <u>Task 6.2.2</u> Apply, acquire, and manage DHS funding through the State.
 - <u>Task 6.2.3</u> Maintain accurate records of purchases and remit timely progress reports with submissions of reimbursement for revenues.
 - <u>Task 6.2.4</u> Acquire supplemental reimbursements for Disaster Declarations, incident reimbursements, and responsible party situations.
 - Task 6.2.5 Research and compile information to support the need for any fees for services.
- **6.3** Maintain NIMS Compliance in order for NCC to remain eligible for federal grants.
- **6.4** Maintain data for existing accreditation and strive for accreditation of OEM through the EMAP process.
 - <u>Task 6.4.1</u>- Continue to record and document compliance with CALEA standards on an annual basis.
 - <u>Task 6.4.2</u> Complete an initial self-assessment on the feasibility of acquiring EMAP Accreditation.

Instilling a "Culture of Preparedness" in all citizens must be done through the encouragement of planning for vulnerabilities, increasing awareness and access to information, improving technology, and promoting communication, consensus-building, and volunteerism.
